Reasons to change your solicitor

When making a claim it can be difficult to know what to do, especially if you are unfamiliar with the legal process. Of course you will likely carry out as much research as possible to find the best solicitor to carry out your claim, however you may still feel part way through your claim, the need to change solicitor. This could be for a number of reasons:

Your claim has started with the solicitor you instructed, but you now believe that they don't understand your claim or don't understand why you are making the claim and its importance to you.

You may also feel, that the claim is not being handled by your solicitor in the correct way. At this point you may feel it is the best option for yourself and your chances of success, to receive a second opinion from another solicitor. This will help you gauge whether what is happening is correct and you can make a more informed decision.





Your solicitor leaves the firm

When a solicitor leaves their firm during a case, it is normal practise for your claim to be passed on to someone else within the firm, however you may decide at this point that you would like to instruct a completely different firm.

The firm has closed down

If the law firm closes during your claim, you will have little choice but to take it to another firm. This may leave you at a crossroad, unsure where to go. The service doesn't meet your standards

Your claim is important to you and an important part of moving on with your life. You may feel that the solicitor or firm you have instructed is no longer acting in your best interests, or you are not receiving the service you are entitled to. This could be due to multiple reasons, such as not being kept up to date by your solicitor, your solicitor taking actions you don't believe are right for you, or the speed at which the claim is progressing. If this is the case, you are entitled to change your solicitor.

How to change solicitors in 3 simple steps

You've made the decision to change your solicitor, this is not always simple or an easy decision, especially if your claim is complex and/or potentially high value. However, you have decided a change is the best action to ensure the best possible outcome for you and your loved ones is achieved.

Do your research

Do your research based upon the factors we have outlined above and choose a new solicitor/law firm to carry your claim forward. The best way to do this is contact them via email or telephone and speak to your new proposed solicitor. Make sure the new solicitor speaks and/or meets with you on a free, no obligation basis.

Sort your legal fees

The next step is sorting your legal fees with your previous solicitor. Your new solicitor may be able to help with this. You will need to agree how your incurred legal fees will be dealt with, if relevant; whether this is as soon as you change or at the end of your claim. Often, especially if you are on a no-win no-fee agreement with your solicitors, they will be happy to transfer the file as long as the new firm agrees to preserve their right to recover the fees if the case settles. This is common in the legal industry.



Sign the form of authority

When that is agreed, your new solicitor will ensure you complete and sign a Form of Authority. This is then sent to your previous solicitor who will then release of your file of papers to your new solicitor.
